# **PHAC** – the basics

**Mission:** To promote and protect the health of Canadians through leadership, partnership, innovation and action in public health.

Vision: Healthy Canadians and communities in a healthier world.

### Mandate

Our role is to:

- Promote health
- · Prevent and control chronic diseases and injuries
- Prevent and control infectious diseases
- Prepare for and respond to public health emergencies
- Serve as a central point for sharing Canada's expertise with the rest of the world
- Apply international research and development to Canada's public health programs
- Strengthen intergovernmental collaboration on public health and facilitate national approaches to public health policy and planning.

## **Additional Background**

- Established in 2004, in part as a response to the 2003 SARS outbreak
- Enforces the Human Pathogens and Toxins Act and Human Pathogens and Toxins Regulations
- PHAC is one of six departments and agencies that make up the federal government's Health Portfolio and reports to Parliament through the Minister of Health
- Managed by the President, currently Siddika Mithani
- Chief Public Health Officer (CPHO), currently Dr. Theresa Tam, is the lead health professional of the Government of Canada in relation to public health. CPHO publishes an Annual Report on the State of Public Health in Canada

#### Did You Know

FluWatch is Canada's national surveillance system that monitors the spread of flu and flu-like illnesses on an on-going basis.
