# **Committee Reports**

# **Communications, Engagement and Technology**

# **Professional Development: Results-Based Management (RBM) Foundations Program Courses**

- Over the past two years (during the pandemic) we developed a new business model to manage and expand PPX capacity to offer professional courses (beyond the conventional pre-symposium courses)
- The Program is a suite of two courses RBM Principles and Basics and RBM Functions and Tools that together are designed to provide participants with the fundamental knowledge, skills, methods, and templates commonly used to manage performance in the public sector. While the focus of the course is principally on the Government of Canada, the program also covers a range of examples drawn from provincial and international experiences.
- The courses were delivered online in the Spring and Fall of 2022 and reached a total of 70 participants from across Canada. Feedback from attendees suggested that the information received was highly applicable to their work and that the online delivery has been good and improving. As an example where as the % of respondents to an after class survey saying that they were 'very likely' to use the information received after week 1 was just under 70% in 2021, it averaged over 80 % in 2022.
- Some of the key areas of value were found to be the use of well referenced open access sources, connections to actual Government of Canada (and other) work and the use of practical, linked case examples. The use of short compelling videos and guest presenters as part of the program was also seen as important along with the creation of discussion opportunities to the extent possible online.
- Through online courses, we increased the reach of our audience outside Ottawa across the country, including from Yukon.

- Developed new collaborations with universities (eg. University of Ottawa) and inputs/support from TBS (increased credibility).
- In 2022-2023, we offered the RBM courses twice (Fall and Winter) ideally, we want to offer them 3 times a year.

# Symposium

- The PPX 25<sup>th</sup> Virtual Symposium took place on October 12 and 13, 2022. Although initially planned for May this year, a severe weather event resulted in postponement to October.
- PPX also presented a suite of two training courses, The Results-Based Management (RBM) Foundations Program: "RBM Principles and Basics" and "RBM Functions and Tools."
- The Symposium and the courses were a success:
  - The training courses were sold out
  - Symposium attracted approximately 200 paid registrants.
- The theme of the Symposium, "Planning and Performance for a More Resilient Future," reflected the significant impacts of the global pandemic on governments, organizations and people around the world, and the challenge of building a more resilient future.
- The Sub-Themes were:
  - Using Results to Manage: Integrating the Key Elements
  - Diversity, Mental Wellness and Inclusion: The Challenges of Planning, Measuring and Demonstrating Impacts
  - Final Keynote was titled "What Resilience Means?" Featuring Dr. Lisa Bélanger

# **SSHRC Research Project**

Led by Rob Shepherd (Carleton University), Evert Lindquist (University of Victoria) and a team of researchers, the project brings together academics and practitioners to examine the design considerations for an anticipated spending/expenditure review exercise at the federal level in Canada, although there are implications for designs of provincial exercises as well.

It aspires to contribute to research on design considerations, but ultimately our longer-term aim is to understand the design decisions made domestically and internationally, and the approaches used and the rationale for each. It draws directly on the expertise of the Performance and Planning Exchange (PPX) to address the question: what are the appropriate design considerations that would inform the

next federal spending review exercise drawing on domestic and international comparisons of past and future.
